## Granskning av bokslut och årsredovisning per 2021-12-31

På uppdrag av Vansbro kommuns revisorer har KPMG översiktligt granskat bokslut och årsredovisning för räkenskapsåret 2021. Syftet med granskningen har varit att ge kommunrevisorerna ett tillräckligt underlag för revisionsberättelsen. Revisorerna har följande synpunkter på redovisningen:

- Vi bedömer att målen för god ekonomisk hushållning inte omfattar eller har utvärderats för kommunkoncernen som helhet.
- Vi rekommenderar kommunstyrelsen att ta fram mål med betydelse för god ekonomisk hushållning för kommunkoncernen.
- Vår sammanfattande bedömning är att resultatet enligt årsredovisningen delvis är förenligt med de av fullmäktige fastställda finansiella målen då ett av de fyra målen inte bedöms ha uppnåtts.
- Vår sammanfattande bedömning är att resultatet enligt årsredovisningen inte är förenligt med de av fullmäktige fastställda verksamhetsmålen för god ekonomisk hushållning då inget av de strategiska målen bedöms vara uppfyllda.
